Re: Vacancy in the 18th Judicial Circuit of Virginia, Alexandria Juvenile and Domestic Relations District Court

Dear Governor Northam, Senator Obenshain, and Representative Bell:

On behalf of the Virginia Women Attorneys Association ("VWAA"), a regional committee (the "Committee") was impaneled to evaluate candidates for an anticipated vacancy in the 18th Judicial Circuit of Virginia, Alexandria Juvenile and Domestic Relations District Court.

The VWAA requested that interested candidates complete the VWAA Judicial Candidates Questionnaire (the "Application"), submit a short biography, and participate in an interview with the Committee. On June 18, 2019, the Committee interviewed seven (7) candidates.

It is worth noting that the VWAA ratings are based upon a review of each candidate's merits against published standards and guidelines, including the following: fairness, integrity, experience, intellect, temperment, professionalism, and *pro bono* service. Ratings are not a function of a general vote by the VWAA membership, nor are they a comparison of candidates within the "pool" presented.

The following rating categories are used by the VWAA:

- (1) NOT QUALIFIED: Applied to any applicant who fails to meet the minimum requirements for fairness, experience, intellect, temperament, professionalism, integrity and/or other basic criteria set forth in the ABA Guidelines.
- (2) QUALIFIED: Applied to any applicant who meets the minimum requirements for fairness, experience, intellect, temperament, professionalism, integrity and/or other basic criteria set forth in the ABA Guidelines.
- (3) RECOMMENDED: Applied to any applicant whose qualifications are sufficiently above the minimum requirements for fairness, experience, intellect, temperament, professionalism, integrity and/or other basic criteria set forth in the ABA Guidelines to warrant the Committee's affirmative recommendation.
- (4) HIGHLY RECOMMENDED: Reserved for any candidate who is especially well-qualified for the position and merits special recommendation.

The VWAA's procedures provide that ratings of "Qualified" and "Recommended" require a vote in support by at least a simple majority of the Committee. A rating of "Highly Recommended" requires a vote in support by at least a two-thirds majority of those voting. In order for the Committee to find that a candidate fails to meet the minimum qualifications and is "Not Qualified," at least two-thirds of those voting must so find.

The Executive Committee of the Board of Directors of the VWAA approved, in accordance with its procedures, the following endorsements of the Committee for this judicial vacancy:

Thomas K. Cullen was found highly recommended.

Mary Elliott O'Donnell was found highly recommended.

Rebecca Wade was found highly recommended.

Karen M. Grane was found recommended. Colleen M. Haddow was found recommended. Tamika Dawn Jones was found recommended.

Douglas A. Steinberg was found qualified.

THOMAS K. CULLEN

Experience and Legal Ability: Thomas K. Cullen earned his Juris Doctor from the Washington College of Law, American University in 1991. He was admitted to practice law in the Commonwealth of Virginia in 1992.

Mr. Cullen has served as a Magistrate in the 5th Magisterial District, 19th Judicial Circuit since January 2019. In that capacity, and inter alia, he conducts hearings to determine probable cause for criminal charges or to set or deny bail, considers the issuance of emergency custody orders (for mental health evaluations) and temporary detention orders (for more in depth mental health evaluations and temporary treatment), and issues arrest and search warrants, as well as protective orders.

Prior to his Magistrate service, Mr. Cullen was a solo practitioner and focused on family law and criminal matters, including representation of both juveniles and adults. He also served as guardian *ad litem* in CHINS, delinquency, custody, visitation and abuse and neglect cases, and represented both juveniles and adults in protective order cases. In addition, Mr. Cullen assisted families as a mediator in developing separation, custody and visitation agreements.
